
A letter dated 18.06.2021 was circulated amongst ICAR Research Institutes with the request to provide the information/details of the AAOs appointed up to 31.12.2020 at their Institutes.

A provisional seniority/eligibility list of AAOs for promotion to the post of AO, thus prepared was circulated vide circular dated 05.08.2021 to invite representations. Later, again the provisional list prepared in accordance to RRs was circulated vide Council's letter dated 04.08.2022 inviting representations/objections of stakeholders. PwBD category information was also sought simultaneously.

Subsequently, provisional seniority/eligibility list incorporating the PwBD category information received from ICAR Institutes was again circulated vide Council's letters dated 20.09.2022 and 01.11.2022 inviting representations. Heads of administration of institutes were also requested to inform regarding any discrepancy in details given in seniority/eligibility list. Representations/Submissions received on various occasions, where ever admissible in accordance to criteria of seniority as given in Recruitment rules of the post of AO, have been suitably incorporated.

Now the seniority/eligibility list of AAOs for promotion to the post of AO, as on 31.12.2020 has been finalised with the approval of the competent authority and is circulated herewith for information of all concerned.


